- viii. Statement of the bidder's Single Largest Completed Contract (SLCC) similar to the contract to be bid in accordance to ITB Clause 5.4, within five (5) years from the Submission and Opening of Bids, *must be at least fifty percent (50%) of the ABC.*

For this purpose, similar contracts shall refer to ***“Supply, Delivery, Installation and Commissioning of Any Hospital Bed or Stretcher Bed”***

The statement shall include, for each contract, the following:

**vi. After Sales Service:**

- Bidder's Certificate that parts shall be available at the authorized Philippine service center/s for a period of five (5) years after the warranty period.
- Certification from local distributor on the availability of service technicians and/or biomedical engineers in case of equipment breakdown.

**vii. Preventive Maintenance:**

- Bidder's Certificate Free Quarterly Preventive maintenance during the warranty period with preventive maintenance plan.

**viii. Warranty Certificate:**

- Warranty Certificate minimum of THREE (3) years for SERVICE and ONE (1) year for PARTS. The warranty period shall commence from the date of acceptance by the end-user after testing and commissioning.

**Financial Requirements:**

- Completely filled out EAMC Price Quotation Form.** Bidder must fill in the ff: bid price per unit, amount in words, bidder's specifications, brand and country of origin. Failure to comply shall be the ground for disqualification.
- Price Proposal in company's letterhead
- Bidder should provide a separate **Compact Disc** (CD-R, CD-RW, DVD-R, DVD-RW, etc.) or **Universal Serial Bus (USB)** containing the Price Quotation List in an **excel file**. Only one (1) Compact Disc or USB is required to be included in the Original Financial Folder.

Bidders shall submit two (2) copies of their proposal in a **RED** colored envelope properly labelled and sealed. The First Copy marked as 'ORIGINAL'; the Second Copy marked as 'COPY 1'. All of the two (2) copies shall contain the all the Requirements in a folder.
